LOCAL GOVERNMENT NOTICE: INTENTION TO ENTER INTO LONG TERM CONTRACTS IN TERMS OF SECTION 33 OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE ACT, (ACT 56 OF 2003)

Notice is hereby given in terms of Section 33 of the Local Government: Municipal Finance Management Act, No. 56 of 2003 that Bergrivier Municipality intends entering into the following long term contracts:

1. **Tender no: 8/3/61-2021 (MN276/2021): The compilation and maintenance of the general valuation roll and the supplementary valuation rolls as well as other valuation related services for the period 1 July 2023 to 30 June 2028:** This contract is for the compilation and maintenance of the Municipal Valuation Roll. The validity of the valuation roll is 5 (five) years, from 1 July 2023 to 30 June 2028
2. **Tender no: 8/3/1-2022 (MN5-2022): Appointment of a service provider for the licensing, upgrade and support of an Integrated Municipal Financial Management System (ERP) and Municipal Standard Chart of Accounts (MSCOA) for a period of 9 years and 11 months:** This contract is for the licensing, upgrade and support of the Financial Management System **in use** by the Municipality and must adhere to criteria as determined by the National Treasury. The duration of the contract is for 9 years and 11 months.

These contracts will impose financial obligations on the Municipality for a period longer than the three years covered in the budget (Medium Term Revenue and Expenditure Framework) from the financial year 2022/2023 onwards.

Notice is further given in accordance with Sections 21 and 21A of the Local Government Municipal Systems Act, (Act 32 of 2000), inviting the local community and other interested persons to submit comments or representations to the Municipality in respect of the proposed draft contract. Such comments or representations must be received via electronic mail, be delivered at the physical address hereunder or mailed to the mailing address provided hereunder within 30 days. Submissions must be clearly marked, with the relevant Tender Number above as reference.

Copies of the draft contracts and information statement summarizing the Municipality's obligations in terms of the draft agreements are available for inspection at Bergrivier head office in Piketberg.
