TENDERS are hereby invited from competent and experienced contractors for for the installation of flow meters on the rising mains of Velddrif sewer pumpstation as well as other minor alterations to the existing pumpstation. **It is estimated that bidders should have a CIDB grading of 3CE or higher and must provide valid proof thereof.** CIDB registration shall be valid on the date of tender submission.

Bids, in sealed envelopes, clearly marked "**Tender No. T8/3/42-2025 MN 216/2025: Installation of flow meters and alterations to existing sewer pumpstations in Velddrif**", must be placed in the tender box at the Municipal Offices, 13 Kerk Street, Piketberg no later than **12:00 on Monday, 03 November 2025**, when the bids will be opened in public. **Bids addressed to any municipal official in his/her personal capacity will not be considered and will immediately be disqualified. It is the bidder's responsibility to make sure that bids are being placed in the tender box by courier companies. The Municipality will not be held accountable for any bids not being placed in the tender box by courier companies.**

Tenders must be valid and binding for one hundred and twenty **(120) days** after closing date

A compulsory clarification meeting will be held on Tuesday, 14 October 2025 at 11h00 at Noordhoek Public Library in Velddrif on the corner of Albatross and Kerk Street, Noordhoek Velddrif, (-32.773863, 18.166002).

Bids will be evaluated using the Council's Supply Chain Management Policy. It is therefore compulsory that the Preference Point Claim form for the Preferential Procurement Regulations is completed in full to make application for preference points of **80 points for price, 10 points for specific participation goals and 10 points for BBEE.** The **Bid price must be VAT inclusive.**

Bidders must be registered as a prospective supplier on National Treasury's Central Supplier Database (CSD). The Tax Clearance Certificate/ Tax Compliance Status (TCS) Pin/ Centralised Suppliers Database (CSD) Registration Number must be submitted together with the bid. Failure to submit a Tax Clearance Certificate/TCS Pin/CSD registration number may result in the invalidation of the bid.

Only bids **completed in black ink** on the original Bid documentation will be accepted. Late, incomplete or Bids submitted by facsimile or email will not be accepted. Proof of submitting a Bid will not be accepted as proof of the Bid having been received. The Municipality is not obliged to accept the lowest or any Bid submitted to it. The Municipality reserves the right to accept any Bid in full or in part. If prices offered are cost effective Council reserves the right to procure more items to take financial advantage thereof.
