

**TENDER T 8/3/64-2024 (MN301-2024) : UPGRADING OF THE B-FIELD AT PELLA PARK SPORTSGROUND IN PORTERVILLE**

**TENDERS** are hereby invited from competent and experienced contractors for the UPGRADING OF THE B-FIELD AT PELLA PARK SPORTSGROUND IN PORTERVILLE. **It is estimated that bidders should have a CIDB grading of 2CE or higher and must provide valid proof thereof.** CIDB registration shall be valid on the date of tender submission.

Bids, in sealed envelopes, clearly marked "**TENDER T 8/3/64-2024 : UPGRADING OF THE B-FIELD AT PELLA PARK SPORTSGROUND IN PORTERVILLE**", must be placed in the tender box at the Municipal Offices, 13 Kerk Street, Piketberg no later than **12h00 on Monday, 09 December 2024**, when the bids will be opened in public. **Bids addressed to any municipal official in his/her personal capacity will not be considered and will immediately be disqualified. It is the bidder's responsibility to make sure that bids are being placed in the tender box by courier companies. The Municipality will not be held accountable for any bids not being placed in the tender box by courier companies.**

The work comprises the civil engineering construction of a 120 m x 70 m gravel platform that will form the foundation of a multi-purpose sports field. Grass sods and seeds will be imported and placed on the fertilized topsoil to cover the proposed playing field area of 8400 m<sup>2</sup>.

**A compulsory clarification meeting will be held on Monday, 25 November 2024 at 11h00, at Bergrivier Municipality's Library, Mark Street in Porterville and from there to Pella Park Sportsground. Doors will be closed at 11h05 and no entry allowed after specified time.**

Bids will be evaluated using the Council's Supply Chain Management Policy. It is therefore compulsory that the Preference Point Claim form for the Preferential Procurement Regulations is completed in full to make application for preference points **of 80 points for price, 10 points for specific participation goals and 10 points for BBEE. The Bid price must be VAT inclusive.**

Bidders must be registered as a prospective supplier on National Treasury's Central Supplier Database (CSD). The Tax Clearance Certificate/ Tax Compliance Status (TCS) Pin/ Centralised Suppliers Database (CSD) Registration Number must be submitted together with the bid. Failure to submit a Tax Clearance Certificate/TCS Pin/CSD registration number may result in the invalidation of the bid.

Only bids **completed in black ink** on the original Bid documentation will be accepted. Late, incomplete or Bids submitted by facsimile or email will not be accepted. Proof of submitting a Bid will not be accepted as proof of the Bid having been received. The Municipality is not obliged to accept the lowest or any Bid submitted to it.
